Important Information

- 1 At the 16th Annual General Assembly (GA16), a resolution was adopted to implement a new voting format to achieve a more balanced representation of the membership sectors in the GA voting process.
- 2 It requires each resolution tabled for approval at the GA to have proponents from at least three (3) of the seven (7) membership sectors.
- 3 For a resolution to be passed:
 - A simple majority of the votes is required;
 - Vote calculations are based on all votes, including abstained votes.
- 4 The voting weightage for vote calculation shall reflect the composition of the RSPO Board of Governors.

Membership Sector	Voting Weightage %
Oil Palm Growers	25.0%
Palm Oil Processors and/or Traders	12.5%
Consumer Goods Manufacturers	12.5%
Retailers	12.5%
Banks and Investors	12.5%
Environmental NGOs	12.5%
Social NGOs	12.5%
